COMPANY REQUIREMENTS 2011-2012 DANCE YEAR

**TO BE ELIGIBLE FOR THE COMPANY:**

DANCERS MUST TAKE BALLET **AND** TECHNIQUE

**TO BE ELIGIBLE FOR POINTE:**

DANCERS MUST TAKE BALLET, TECHNIQUE, CONTEMPORARY AND/OR LYRICAL AND A FOURTH CLASS OF YOUR CHOICE.

**TO BE ELIGIBLE FOR A PRIVATE CLASS:**

DANCERS MUST TAKE A MINIMUM OF 5 CLASSES PER WEEK (DOES NOT INCLUDE TECHNIQUE).

**COMPANY DRESS CODE:**

LEOTARD AND TIGHTS (ANY COLOR/ANY STYLE)

TIGHT-FITTING BOY SHORTS (ANY COLOR/ ANY STLE)

BALLET SKIRTS (ANY COLOR/ANY STYLE)

JAZZ PANTS (ANY COLOR /ANY STYLE)

TIGHT CAPRI OR ANKLE LENGTH LEGGINGS (ANY COLOR/ANY STYLE)

SHRUG (ANY COLOR/ANY STYLE)

LEGWARMERS (ANY COLOR/ANY STYLE)

SMALL EARRINGS ONLY

**ALL OTHER CLOTHING ITEMS ARE NOT TO BE WORN TO CLASS.**

HAIR **MUST BE IN A BUN** FOR TECHNIQUE AND BALLET. A SECURE PONYTAIL IS ACCEPTABLE FOR OTHER CLASSES. PLEASE NOTE- IF AN INSTRUCTOR ASKS HAIR TO BE WORN A SPECIFIC WAY, YOU MUST ADHERE TO THAT RULE!

PLEASE CHOOSE YOUR CLASSES CAREFULLY – AFTER THE 2011-2012 DANCE YEAR, DANCERS THAT CHOOSE TO ADD NEW CLASSES MUST TAKE THOSE CLASSES AT A NON-COMPANY LEVEL. AT THE LEVEL IN WHICH OUR COMPANY DANCERS ARE PROGRESSING, IT IS NOT POSSIBLE TO INTEGRATE DANCERS WITH NO PRIOR EXPERIENCE IN A CERTAIN DISCIPLINE WITH THOSE THAT HAVE YEARS OF EXPERIENCE.
